

C.A.T. CONSENT FORM

- I am the registered owner and entitled to possession of the listed vehicle.
- I understand that my signature indicates I am a voluntary participant in the Combat Auto Theft program of the Bartow Police Department.

- I hereby waive any and all claims I might have against the agencies participating or any of its officers, agents or employees, or any officers, deputies, agents or employees of any other law enforcement agencies resulting if this vehicle is stopped because it is being operated between the hours of 1:00 a.m. and 5:00 a.m.
- I understand that if I am stopped while operating this vehicle between the hours of 1:00 a.m. and 5:00 a.m. it will be necessary for me, or an authorized driver that I have so designated on this form, to furnish a valid driver license, proof of registration and proof of insurance.
- I agree that if I terminate my participation in the Combat Auto Theft Program, or if I transfer or sell this vehicle, I will remove the program decal from this vehicle.
- I accept any and all liability resulting from my failure to remove the program decal.
- I agree to notify the Bartow Police Department of any change of address or authorized drivers. I understand that the CAT program decal is provided only for the vehicle listed on this application and is not transferable to other vehicles.
- I agree to inform all authorized drivers listed of the conditions and requirements of the CAT Program.
