## PUBLIC NOTICE OF ELECTION

Pursuant to Section 100.021, Florida Statutes, notice is hereby given that the City of Bartow will hold a **Regular Election on Tuesday, April 1, 2025 from 7:00 AM to 7:00 PM**, for the election of **ONE** City Commissioner for a three-year term.

### **SEAT 3 – NORTH DISTRICT**

*Incumbent – Trish Pfeiffer*

**QUALIFYING PERIOD** – The candidate qualifying period begins at 9:00 AM on Monday, February 3, 2025 and ends on Friday, February 7, 2025 at 5:00 PM at City Hall, 450 N. Wilson Ave., Bartow.

**QUALIFYING FEE** – The qualifying fee is \$135.71 (1% of annual salary). The salary for a Commissioner is \$1,130.88 per month.

**CANDIDATE REQUIREMENTS** – Candidate(s) must be U.S. Citizen(s), at least 18 years old, a resident of Florida, a registered voter in Florida and in Polk County, reside within the City limits of Bartow continuously for 18 months immediately preceding the date of commencement for the term of office and hold no other public office. ***Candidates seeking to qualify for SEAT NO. 3 (North District), must reside within that district.***

**TERM OF OFFICE** – The term is three years and will commence at the first Regular City Commission Meeting in May 2025.

**CANDIDATE PACKETS** – Candidate packets can be delivered electronically or picked up in person at the City Clerk's Office at City Hall, 450 N. Wilson Avenue., Bartow, FL 33830.

**RUN-OFF ELECTION** – A run-off election, if needed, would be Tuesday, May 6, 2025, from 7:00 a.m. to 7:00 p.m.

**VOTING LOCATION** – All precincts will vote at the **BARTOW CIVIC CENTER, 2250 S. Floral Avenue, Bartow, FL 33830.**

**VOTER INFORMATION** – City of Bartow residents who plan to vote in the April 1, 2025, City of Bartow Regular Election must register to vote by the March 3, 2025 book closing date. Voter registration forms can be found online at [www.polkelections.gov](http://www.polkelections.gov) or by calling the Polk County Supervisor of Elections at (863) 534-5888. Additionally, registered voters who have informational changes or wishes to receive a vote by mail ballot should contact the Polk County Supervisor of Elections.
